Courses Tree

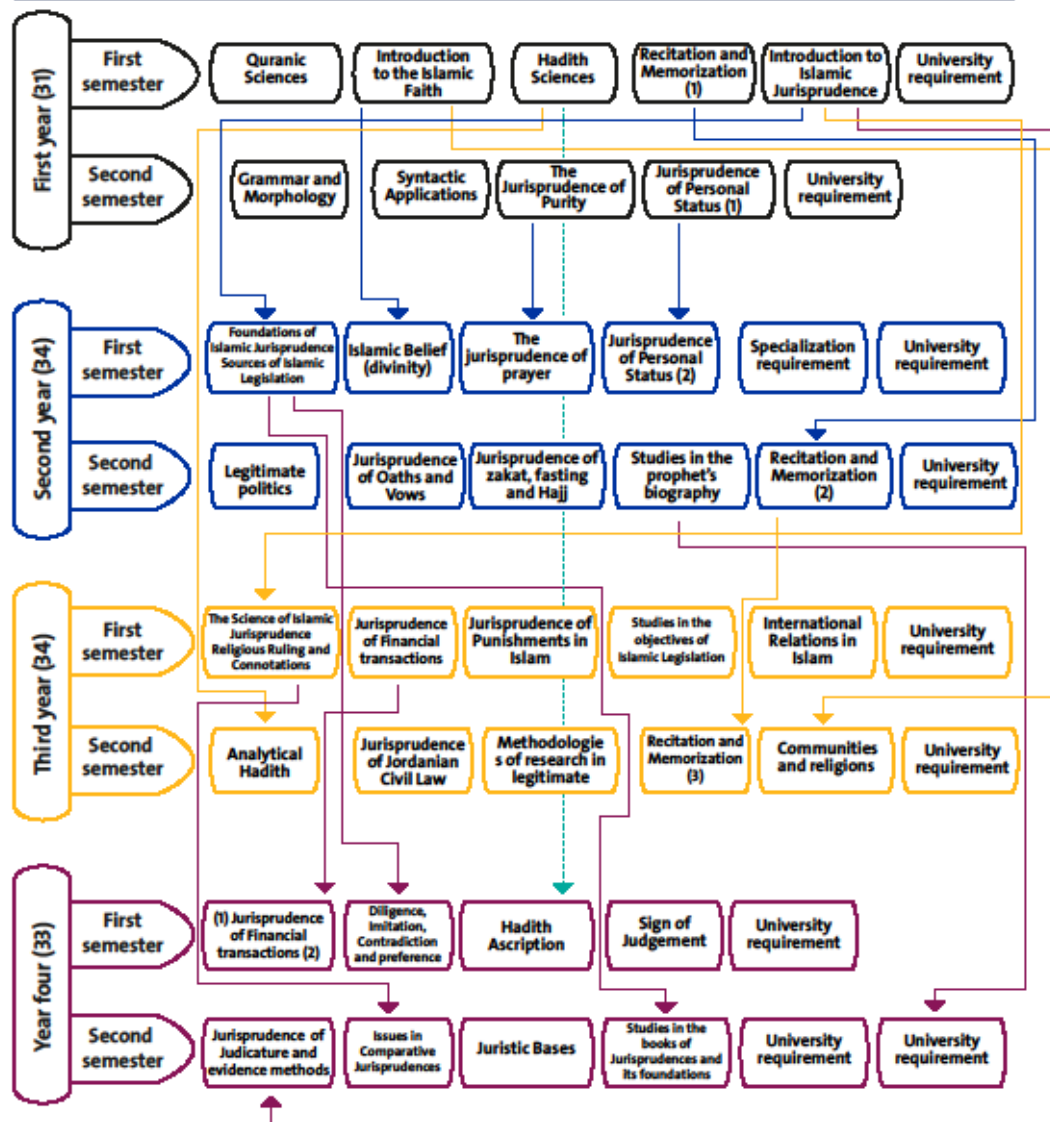

Course Description

90261102 Recitation and Memorization (1), (1) Credit hrs., Prerequisite: None, Blended.

This course will introduce students to the fundamentals of Quran recitation and memorization. Topics covered will include Ranks of recitation; Types of melody; Etiquette of recitation; The rules of silent 'nūn' consonant, Tanween, 'nūn'; the rules of silent 'mīm'; 'nun' and stressed 'mim'; The rules of Qalqalah; Types of intonation and their rules; Memorizing two chapters of the Holy Quran: twenty-ninth and thirty; Reciting the first eight chapters of the Holy Quran. Students will have the opportunity to practice their recitation and memorization skills under the guidance of a qualified instructor.

Note: This course is the first in a three-course sequence on Quran recitation and memorization.

90262203 Recitation and Memorization (2), (1) Credit hrs., Prerequisite: 90261102, Blended.

Places of articulation of sounds, their names, their descriptions, the distinction between Al-Mouraaqq (light sounds) and Al-Muffakham (heavy sounds), memorizing two chapters of the Holy Quran; twenty-seventh and twenty-eighth, and reciting the chapters from nine to the end of chapter sixteen of the Holy Quran.

90263204 Recitation and Memorization (3), (1) Credit hrs., Prerequisite: 90262203, Blended.

Pausing and initiation, and the subtypes of stopping such as Al-rawm and Al-ishmam emphasizing the words that deviate from the general rule of initiation. Memorizing the twenty-fifth and twenty-sixth chapters of the Holy Quran, as well as recitation of the seventeenth to the end of the twenty-fourth chapters of the Holy Quran.

90291101 Introduction to Islamic Theology, (3) Credit hrs., Prerequisite: None, Blended.

This course will introduce students to the fundamental characteristics of the Islamic religion and the status of theology within it. It will explore the terminology and sources of Islamic theology, as well as the correct approach to receiving and reasoning about theological beliefs. The course will also highlight the most prominent groups that have violated the correct creed and refute the suspicions that are raised about it.



90261101 Quranic Sciences, (3) Credit hrs., Prerequisite: None, Blended.

This course will introduce students to the sciences of the Holy Quran (Ulum al-Quran), which is a field of study that encompasses all aspects of the Quran, including: Definition; origin; history; and documentation of the sciences of the Quran; The most important fields of the sciences of the Quran, including Revelation; Collection, codification, and narration of the Quran; The seven dialects; Makki and Madani suras; Readings (Qirā'āt); Translation of the Quran; Abrogation; Miracles; One-meaning and multi-meaning verses; Subtleties of the Quran (lata'if al-Quran), such as general, private, absolute, and restricted verses; Responses to suspicions raised about the sciences of the Quran. The course will be taught using a variety of methods, including lectures, discussions, and readings. Students will have the opportunity to learn about the vast and rich field of the sciences of the Quran and to develop their own critical thinking skills.

90271101 Hadith Sciences, (3) Credit hrs., Prerequisite: None, Blended.

This course will introduce students to the fundamental principles and methods of Hadith criticism (Jarh wa-Ta'dil). Hadith criticism is the process of evaluating the authenticity and reliability of hadith narrations. It is a complex and sophisticated field of study that has developed over centuries. The course will cover the following topics: The definition of hadith and its importance in Islam; The different types of hadith and their classifications; The science of Hadith narrators (Rijal al-Hadith), including the conditions for accepting and rejecting narrators, the books of men, and the process of discrediting and endorsing narrators; The science of Hadith texts (Matn al-Hadith), including the different types of hadith texts and the rules for judging them.

90211101 Introduction to Islamic Jurisprudence, (3) Credit hrs., Prerequisite: None, Blended.

This course will introduce students to the sources of Islamic legislation and jurisprudence, as well as the development of Islamic jurisprudence from the time of the Prophet Muhammad (peace be upon him) to the present day. The course will cover the following topics: The definition of Islamic jurisprudence and its importance in Islam; The sources of Islamic legislation, including the Quran, Sunnah, consensus of the scholars, and analogy; The development of Islamic jurisprudence from the time of the Prophet Muhammad (peace be upon him) to the present day, including the contributions of the Rightly Guided Caliphs, the Companions, and the followers; The characteristics of Islamic legislation in different eras.



90272202 Readings in Prophetic Biography, (3) Credit hrs., Prerequisite: None, Blended.

This course will introduce students to the life and legacy of the Prophet Muhammad (peace be upon him). The course will cover a wide range of topics, including: The period prior to the Prophet's mission; His life before the mission; His mission at the age of forty; His mission during the Meccan period; The most prominent events in the Meccan period; The Hijrah: its concept and implications; The Prophet's conquests: their causes and consequences; The most important political, economic, and social events during the Medinan period; The foundations of the Messenger's relationship with the Jews of Medina; The scientific and methodological dimensions of studying the events of the Prophet's biography; A study of the personality of the Messenger as a husband, educator, and leader; A presentation of various models of his characteristics.

50521205 Syntax and Morphology, (3) Credit hrs., Prerequisite: None, Face-to-Face.

This course will introduce students to the fundamental concepts of Arabic syntax and morphology. Syntax is the study of how words are combined to form sentences, while morphology is the study of the internal structure of words. The course will cover the following topics: Parts of speech, including verbs, nouns, and prepositions; Construction and parsing of sentences; Definiteness and indefiniteness in Arabic; Nominatives and accusatives, and their divisions; Referents; Examples from the Holy Quran, Sunnah, Arabic poems, and the science of morphology.

90211202 Jurisprudence of Purity, (3) Credit hrs., Prerequisite: None, Face-to-Face.

This course will introduce students to the Islamic jurisprudence of purity (fiqh al-taharah). The course will cover the following topics: Definition of purity and its parts; How to be purified from dirt and water; Types of water and their rules; What is valid for cleaning oneself, ablution, and ghusl (ritual bathing); Reasons for doing each of these acts of worship; Conditions, pillars, Sunnah, etiquette, and wiping over the shoes (khafayn) for ablution and ghusl; How to wipe over the shoes, its rules and invalidators; Wiping over the cast and its rules; Tayammum (dry ablution) and its causes, how it is done, and its invalidators.

90212103 Jurisprudence of Worship, (3) Credit hrs., Prerequisite: 90211202, Blended.

This course will introduce students to the Islamic jurisprudence of worship (fiqh al-ibadah). The course will cover the following topics: The call to prayer (adhan) and the establishment of prayer (iqama): its importance, the judgment of the one who neglects prayer, its timing, conditions, pillars, duties, its Sunnah, and invalidators; The prostration of forgetfulness and recitation; The rules relating to congregational and Friday prayers, the two Eids, funerals, fear, rain, and lunar and eclipse prayers.



90212204 Jurisprudence of Zakat, Fasting and Hajj, (3) Credit hrs., Prerequisite: None, Blended.

This course will introduce students to the Islamic jurisprudence of zakat, fasting, and Hajj. The course will cover the following topics:

Zakat: The types of wealth on which zakat is due; The conditions for zakat liability; The amounts of zakat due on different types of wealth; Zakat al-Fitr, its conditions, amount, and time of payment

Fasting: The definition of fasting and its conditions; The Sunnah and invalidators of fasting; Excuses for breaking the fast in Ramadan; Remedies for missed days of fasting; Recommended and discouraged practices during fasting.

Hajj and Umrah: The conditions for performing Hajj and Umrah; The spatial and temporal boundaries of Hajj; The different types of Hajj; The pillars, duties, and Sunnah of Hajj; The prohibitions of Hajj and how to perform it; The rulings on sacrificing.

90213107 Jurisprudence of Financial Transactions (1), (3) Credit hrs., Prerequisite: None, Face-to-Face.

This course will introduce students to the fundamental principles of Islamic financial jurisprudence. The course will cover the following topics: Definition of money, its concept, importance, divisions, and implications; Possession and its types; Sources of commitment in Islamic jurisprudence; Selling, its concept, pillars, conditions, types, and effects; Termination of the sale contract, its concept, pillars, conditions, and effects; Concept of Istisna', its pillars, and conditions.

90214108 Jurisprudence of Financial Transactions (2), (3) Credit hrs., Prerequisite: 90213107, Face-to-Face.

This course will explore emerging contemporary jurisprudential issues in Islamic financial transactions. The course will cover a wide range of topics, including: Investing zakat funds; Insurance; Rent-to-own agreements; Credit cards; Intellectual property rights; Commercial name and trademark; Stocks; Other contemporary financial matters.

90221201 Jurisprudence of Personal Status (1), (3) Credit hrs., Prerequisite: None, Blended.

This course will introduce students to the fundamental principles of Islamic jurisprudence of personal status, with a focus on marriage and divorce. The course will cover the following topics: Definition of the jurisprudence of personal status and marriage contract; Concept, components, and effects of the marriage contract; Methods of ending the marriage contract; Divorce, khul' (divorce initiated by the wife), and separation; Implications of the ending of the marriage contract; Waiting period after divorce; Parentage, breastfeeding, custody, and child support; Relationship between jurisprudence and law in these areas.



90222102 Jurisprudence of Personal Status (2), (3) Credit hrs., Prerequisite: 90213107, Face-to-Face.

This course will introduce students to the jurisprudential rules of inheritance in Islam. The course will cover the following topics: Definition of inheritance and related rights; Prohibitions related to inheritance; Pillars and causes of inheritance; Types of inheritance; Origin of issues; Dependency; Compensation; Inheritance of pregnancy and the missing; Bequests, their provisions, amount, and obligatory bequests.

90223203 Methodology of scientific research in legitimate Sciences, (3) Credit hrs., Prerequisite: None, Blended.

This course will introduce students to the principles and methods of scientific research in legitimate sciences. The course will cover the following topics: The importance of scientific research in legitimate sciences; The goals, methods, and steps of scientific research; Authentication rules; Writing and editing manuscripts; Dealing with sources of paper and digital Islamic studies; Practical training in conducting scientific research.

90234205 Jurisprudence of the judiciary and evidence methods, (3) Credit hrs., Prerequisite: 90211101, Face-to-Face.

This course will introduce students to the jurisprudence of the judiciary and evidence methods in Islamic law. The course will cover the following topics: Definition of the judiciary and its difference from synonyms such as ifta (issuing legal opinions) and arbitration; The importance of the judiciary and its types; The conditions of the judge, methods of employment, control, and dismissal; Some of the jurisprudence of the Judicial Council; Means and methods of proof in Sharia cases, including contemporary methods such as DNA testing and photography.

90232201 Islamic Governance Policies, (3) Credit hrs., Prerequisite: None, Face-to-Face.

This course will introduce students to the principles and practices of Islamic governance. The course will cover the following topics: Definition of legitimate politics and its legitimacy; Importance, objectives, and sources of Islamic governance; Relationship of Islamic governance to sources of legislation; Most important works on Islamic governance; General jurisdiction and its characteristics; Areas of Islamic governance policy: creed, worship, the judiciary, the system of governance and administration, computation, penalties, and the economy.

90233102 International Relations in Islam, (3) Credit hrs., Prerequisite: None, Blended.

This course will introduce students to the Islamic perspective on international relations, both in peace and war. The course will cover the following topics: The nature of international relations in Islam; The foundations of Islamic international relations; The legitimacy of international relations in Islam; The application of the principles of Islamic international relations in the real world.





90233104 Jurisprudence of Punishment in Islam, (3) Credit hrs., Prerequisite: None, Blended.

This course will introduce students to the Islamic jurisprudence of punishment. The course will cover the following topics: Definition of punishment in Islam; Necessity and importance of punishment in Islam; Relevance of punishment to the crime; Divisions of punishment in Islam; Types of punishment according to the crimes: atonement, punishment, and compensation; Misconceptions about punishment in Islam.

90293203 Sects and Religions, (3) Credit hrs., Prerequisite: 90291101, Blended.

This course will introduce students to the study of sects and religions. The course will cover the following topics: The meaning of sects and differences; The judgment of sects and its variety; The legitimate attitude towards sects; The reasons for differences in Islam; The different schools of thought in Islamic history, such as the Ahl al-Sunnah wa al-Jama'ah, the Kalamiyya school, and the Kashfiyya school; The most important sects in Islam, their main ideas and methodologies; The meaning of Sunnis and sects, their major characteristics, and how they receive information; The study of religions, their history, principles, and creeds.

90242101 Foundations of Islamic Jurisprudences: Sources of Islamic Legislation, (3) Credit hrs., Prerequisite: 90211101, Blended.

This course will introduce students to the sources of Islamic legislation, which are the Quran, the Sunnah, Ijma (consensus of scholars), and Qiyas (analogical reasoning). The course will cover the following topics: The nature and authority of each source of legislation; The different types of evidence within each source; The rules for interpreting and applying evidence; The resolution of contradictions between different sources of evidence.

90243102 Foundations of Islamic Jurisprudences: The Legal Rule and Indications, (3) Credit hrs., Prerequisite: 90211101, Face-to-Face.

This course is an introduction to the science of foundations and Sharia judgment. It will cover the following topics: Types of Sharia and positive judgment; Implications of the meaning: specific, general, and common; The use of the utterance in the meaning; How the word indicates the meaning.

90244103 Foundations of Islamic Jurisprudences, Diligence, Imitation, Contradiction and preference, (3) Credit hrs., Prerequisite: 90242101, Blended.

This course is an introduction to the Islamic legal principles of diligence, imitation, contradiction, and preference. The course will cover the following topics: The concept of diligence in Islamic jurisprudence; The different types of imitation and their permissibility; The definition and types of contradiction in Islamic law; The bases of contradiction and the methods of refuting it; How to





create a match between conflicting texts; How to judge ways of preference in case of contradiction.

90233103 Studies in the objectives of Islamic Legislation, (3) Credit hrs., Prerequisite: None, Blended.

This course is designed to introduce students to the objectives of Islamic legislation (Maqasid al-Shari'ah). The course will cover the following topics: The significance of the objectives of Islamic legislation; The reality and definitions of the objectives of Islamic legislation; The characteristics of the objectives of Islamic legislation; The necessary objectives of Islamic legislation; Ways of improving the objectives of Islamic legislation; Applications of the objectives of Islamic legislation; The most prominent effects of the objectives of Islamic legislation.

90244204 Juristic Bases, (3) Credit hrs., Prerequisite: None, Blended.

This course will introduce students to the concept of juristic bases (Usl al-Fiqh) in Islamic law. The course will cover the following topics: Definition of juristic bases, their origin, types, degrees, and importance; Difference between juristic bases and legal rules; Juristic theory and foundational bases; The five juristic bases from which juristic fields are derived.

90244205 Issues in Comparative Jurisprudences, (3) Credit hrs., Prerequisite: 90243102, Blended.

This course will introduce students to the different schools of thought in Islamic jurisprudence and the reasons for disagreement among Islamic scholars. The course will also cover a variety of topics in comparative Islamic jurisprudence, which are decided by the department council each year. Some examples of topics that may be covered include: Reading behind Imam; Reading Alfatihah in prayer; Ablution after eating camel's meat; The reason for prohibiting usury; Pricing; Divorce; Plastic surgery.

90292102 Islamic Theology, (3) Credit hrs., Prerequisite: 90291101, Blended.

This course will introduce students to the core beliefs and teachings of Islamic theology. The course will cover the following topics: The concept of God in Islam; The prophets and revealed religions; The world of angels and jinn; Judgment Day and the Minor and Major Signs of Judgment Day.

90212205 Jurisprudence of Oaths and Vows, (3) Credit hrs., Prerequisite: None, Blended.

This course will introduce students to the Islamic law of oaths and vows. The course will cover the following topics: Definition and legitimacy of oaths; Bases and types of oaths; Factors that affect



the validity of oaths; Oath atonement; Definition and concept of vows; Judgment of oaths and vows; Judgment of keeping oaths; Bases and types of vows.

90244206 Studies in the books of Jurisprudences and their foundations, (3) Credit hrs., Prerequisite: 90242101, Blended.

This course will introduce students to the study of the classic books of Islamic jurisprudence and their foundations. The course will cover the following topics: The original sources of jurisprudence and its foundations Reading sources, analyzing texts, and understanding them Choosing texts from the books of Islamic jurisprudence, such as: Al-Warakat for Al-Juwayni; Rawda fir Al-Nather; Al-Ihkan Fi Usul al-Ahkam; Al-Mowafaqa.

90274104 Hadith Ascription, (3) Credit hrs., Prerequisite: 90271101, Blended.

This course will introduce students to the study of the classic books of Islamic jurisprudence and their foundations. The course will cover the following topics: The original sources of jurisprudence and its foundations Reading sources, analyzing texts, and understanding them Choosing texts from the books of Islamic jurisprudence, such as: Al-Warakat for Al-Juwayni; Rawda fir Al-Nather; Al-Ihkan Fi Usul al-Ahkam; Al-Mowafaqa.

90212106 Jurisprudence of Food, Drinks and Sacrifices, (3) Credit hrs., Prerequisite: None, Blended.

This course will introduce students to the science of hadith ascription, which is the study of the chains of transmission of hadiths. The course will cover the following topics: The definition and importance of hadith ascription; The different types of hadith ascription; The methods of evaluating hadith ascriptions; The application of hadith ascription to the judgment of food, drinks, sacrifices, and hunting in terms of legitimacy, conditions, applications in life, and newly emerging relevant issues.

90273102 Hadith of Judgements, (3) Credit hrs., Prerequisite: None, Blended.

This course will introduce students to the hadiths that discuss legal judgments in various fields, such as worship, treatment, and other aspects of life. The course will cover the following topics: The different types of hadiths that discuss legal judgments; The methods of interpreting hadiths that discuss legal judgments; The application of hadiths that discuss legal judgments to real-world situations; The discussion of opinions of Sharia scholars and approving the optimal opinion based on semantic implications of the text.



90294203 Studies in Islamic Theology Books, (3) Credit hrs., Prerequisite: 90291101, Blended.

This course will introduce students to the study of the classic books of Islamic theology. The course will cover the following topics: Textual reading from the references of Ahl al-Sunnah as to Islamic creed; Understanding faith terminology; Training and guidance to understand the phrase of the ancient scholars of the beliefs; Knowing the approach of the ancient scholars of the beliefs in responding to the appeals directed against the Islamic creed.

90214107 Contemporary Jurisprudence Issues, (3) Credit hrs., Prerequisite: 90243102, Blended.

This course will introduce students to emerging contemporary jurisprudence issues. The course will cover a variety of topics, such as: Investing zakat funds; Insurance; Donating organs; Cosmetic surgery; Intellectual invention rights; Commercial name; Trademark; Stocks; Bonds.

90293104 Jurisprudence of invitation and Speech, (3) Credit hrs., Prerequisite: None, Blended.

This course will introduce students to the Islamic law of invitation and speech. The course will cover the following topics: The meaning of mission and its sources; The topics, means, methods, and approaches of mission; The qualities of missionaries and invitees; The significance of speech and its role in the mission to God; The controls on speech; Practical applications of the Islamic law of invitation and speech.

50521206 Syntactic Applications, (3) Credit hrs., Prerequisite: None, Face-to-Face.

This course will introduce students to syntactic applications in Arabic. The course will cover the following topics: Types of parsing; Bases and skills of parsing; Application of parsing to religious texts; Parsing texts from the Quran, hadith, poetry, and prose *Revealing syntactic and linguistic phenomena in texts.

90263105 Verses of Legislations, (3) Credit hrs., Prerequisite: None, Face-to-Face.

This course will introduce students to a selected chapters of the Holy Quran, focusing on the legislative verses. The course will cover the following topics: Maintaining a topic unity of the Quran's chapters; Illustrating and analyzing terms of each chapter and reasons for the revelation; Revealing areas of rhetorical miracles in the Quran and linking them with current reality.

**90113203 Analytical Hadith, (3) Credit hrs., Prerequisite: None, Blended.**

This course will introduce students to an analytical study of a series of selected hadiths from various fields. The course will cover the following topics: Thorough analysis of the hadiths in terms of attribution; Direction to students to practice the teachings of the hadiths.

90283201 Jurisprudence of Jordanian Civil Law, (3) Credit hrs., Prerequisite: None, Blended.

This course will introduce students to the jurisprudence of Jordanian civil law. The course will cover the following topics: Origin of Jordanian civil law; Sources of Jordanian civil law; General provisions of Jordanian civil law; Personal rights; Kinds of contracts with provisions and effects; Real rights and their provisions; Subjects of law that correspond to provisions of Islamic jurisprudence.

90243208 Special topics in Islamic law, (3) Credit hrs., Prerequisite: None, Blended.

Studying issues in Islamic law, jurisprudence, and Islamic economics in all fields of knowledge.

90263206 The miracle of the Holy Quran, (3) Credit hrs., Prerequisite: None, Blended.

Studying the science of the miracle of the Holy Qur'an in terms of its concept and origin, and the most important aspects of the Qur'anic miracle according to ancient and contemporary scholars, studying applied models of it, and refuting the doubts raised about the Qur'anic miracle.
