THIS STUDY FOCUSES ON EXPLORING THE ROOTS OF THIS LEGAL PERSONALITY OF WAQF IN THE SOURCES OF ISLAMIC LEGISLATION, THE OPINIONS OF JURISTS, AND THEIR INTERPRETATIONS, WHICH HAVE BEEN RECOGNIZED BY MANY ARAB LAWS, INCLUDING JORDANIAN AND EGYPTIAN LAW. THE RESEARCH IN THIS STUDY IS CENTERED ON THE ELEMENTS OF THE LEGAL PERSONALITY OF WAQF, ITS PROVISIONS, ITS SCOPE, THE DEBATES SURROUNDING IT, AND THE SYSTEM OF THE RELATIONSHIP BETWEEN THE LEGAL PERSONALITY OF WAQF IN LAW AND ISLAMIC LEGISLATION. IT ALSO EXAMINES WHETHER ITS LEGAL PROVISIONS ALIGN WITH THE PROVISIONS OF ISLAMIC SHARIA
